RULES AND REGULATIONS OF SAFE OPERATION OF THE SHOOTING RANGE located at ul. Puławska 561

Part 1

Terms and conditions of using the shooting range

- 1. The shooting range is destined for shooting training using: pneumatic weapons, rimfire weapons, centrefire weapons of 12 mm calibre with standard soft core cartridges, with the muzzle energy of no more than 2,500 J. Users may also shoot from long arms with the muzzle energy up to 3,500 only when seated (test-firing) and while shooting from 12 mm smoothbore weapons.
- 2. The shooting range may be used by: everyone provided that they comply with all the safety rules and regulations and the provisions of law regarding the use of firearms pursuant to the Act of 21 May 1999 on firearms and munition (as amended and taking account of secondary legislation).
- 3. Entry to the shooting range in order to shoot is allowed following all the necessary formalities arranged at the reception and the person conducting shooting instructor on duty (verification of the permit, getting familiar with the rules and regulations of the shooting range and safety conditions).
- 4. Having entered the shooting range, the user reports to the person conducting shooting instructor on duty who indicates the shooting booth for the users and the place to stay for those who accompany them.
- 5. The person conducting shooting:
 - 1) shall be responsible for the safety of shooting range users, people who accompany them and shall be familiar with the terms and conditions of shooting range use.
 - 2) shall indicate shooting booths for shooting range users and a place where those who accompany them may be safe,
 - 3) shall keep a register of shooting range users and take note of the following data:
 - a) name and surname of a shooting range user,
 - b) weapon permit number and name of the body that issued it or the address of a shooting range user if they do not have a weapon permit,
 - c) statement of a shooting range user that they are familiar with the rules and regulations of the shooting range and safety rules and regulations, signed by their own hand.
- 6. At the shooting range it shall be forbidden:
 - 1) for the persons accompanying shooting range users to enter shooting booths and to have any contact with the weapon,
 - 2) to use the weapon of other shooting range users without their consent,
 - 3) to consume alcohol or use drugs and it shall be forbidden for persons under the influence of alcohol or drugs to stay at the shooting range,
 - 4) to shoot with armour-piercing, chemical, incendiary and tracers munition,
 - 5) to throw grenades.

- 7. The following shall be put in a visible place at the shooting range:
 - 1) the rules and regulations of the shooting range,
 - 2) decision on approving the shooting range for use,
 - 3) shooting range plan on which the following shall be marked:
 - a) shooting booths,
 - b) health section,
 - c) escape routes,
 - d) places where a phone or other communication devices are installed.
 - 4) list of alarm signals,
 - 5) information on the possibility and the manner of communicating with the nearest medical assistance centre.
- 8. The shooting range owner or administrator, the person conducting shooting or shooting training or shooting range users shall be liable for any damage occurred during shooting or causing an accident, on the conditions set out in separate provisions.

Part 2

Weapon handling

- At the range, outside the shooting booth, users shall carry unloaded weapons with the firing chamber open, without any belts and cases. Pistols and revolvers may be carried in holsters. If the rules and regulations of a competition so provides, another manner of carrying weapons shall be allowed.
- 2. Weapon may be taken out in shooting or training booths only when the person conducting shooting or shooting training so decides.
- 3. Any activaties connected with weapon handling shall be done only with the barrel pointing to the butt, targets or items being targets at the shooting range.
- 4. Shooting shall start only as a reaction to a command of the person conducting shooting.
- 5. Shooting termination shall be reported to the person conducting shooting.
- Following shooting termination weapons shall be unloaded and presented for inspection to the person conducting shooting. Users shall leave the shooting booths carrying the weapon with the firing chamber open.
- 7. Shooting and aiming at the shooting range shall be performed only at indicated shooting booths, to targets or other items being targets at the shooting range.

Part 3

Comportment of persons staying at the shooting range

- Shooting range users shall always follow the instructions given by the person conducting shooting.
- 2. It shall be forbidden to enter through a shooting booth without the consent of the person conducting shooting.
- 3. Shooting range users, except for disabled persons, shall abide by the provisions on attitudes expected of shooters.
- 4. Following the command "STOP" given by the person conducting shooting or by another person, shooters shall immediately cease shooting.
- 5. Animals may enter the area of the shooting range only in exceptional cases and they shall at all times be kept on a leash and supervised by the carer.
- 6. Any person who fails to comply with the rules and regulations of the shooting range may be removed from the shooting range.
- 7. Children may stay at the shooting range only when directly supervised by their parents or carers
